If balance due to Metals USA Building Products, L.P. is not fully paid by the 30th day following the invoice date, the company and I agree to pay Metals USA Building Products, L.P. interest on the principal amount unpaid at a rate to eighteen percent (18%) per year or the maximum rate permitted by law, whichever is less.

It is understood that this Guaranty Agreement is to apply to any and all goods or merchandise sold to buyer during the period beginning with the hereof and extending to a time when written notice of the cancellation hereof shall have been received by Metals USA Building Products, L.P. by registered mail and shall cover any such purchases made upon Open Account or evidenced by Note or other instrument incurred during the period of this guaranty.

It is further understood that this guaranty shall not be waived or otherwise impaired by any extension of time for payment to buyer by any other means other than the express agreement of the parties hereto.

This agreement shall endure to the benefit of the successors and assigns of Metals USA Building Products, L.P. and shall be binding upon the successors and assigns of the guarantors.

In the event it becomes necessary to enforce the terms hereof, guarantors agree to pay all costs of collection, including a reasonable attorney's fee.
